Orchestra

There will be no auditions at the camp. Neither will we ask for your grade level, which is an inaccurate measure at best. Instead, please just tell us which orchestra you would like to start in. Our tutors may move you if they think you are misplaced.

- Preludio Strings
You must be able to read basic music in the key of D major. D major looks like [this](#).
- Melaleuca Orchestra
Your must be able to fluently read music in C, G or D major, and A, E or B minor (0 to 2 sharps). Your music will (usually) be in first position.
- Lemonthyme Orchestra
You must be fluent in E flat to A major and C to F sharp minor (3 flats to 3 sharps). You must be able to sight-read in these keys up to third position (violins and violas) or fourth position (cellos).
- Freycinet Orchestra
Repertoire for this orchestra includes unabridged classical scores. You will be expected to sight-read these through once, then work on phrasing and articulation, without needing to repeat sections just to get the basic notes right.

Code of Conduct

This Code of Conduct sets out the RSSC Committee's expectations of the minimum standards of behaviour for everyone at Residential Summer String Camp, including both staff and students.

It is based on the core ethical principles of

1. Respect for the RSSC Committee's aims.
2. Respect for Others
3. Respect for Rules

1. RSSC Committee Aims

To foster the wider knowledge and appreciation of string instruments and classical music in Tasmania, to make this experience interesting, challenging and enjoyable, and to bring participative music to string players from all areas, ages and walks of life.

2. Respect for Others

Showing respect for others

- Treat all people, regardless of age, gender and ethnic background, with respect, courtesy and honesty, and give everyone a fair hearing.
- Respect the dignity, rights and views of others, including different values, beliefs, cultures and religions.
- Take special care to maintain co-operative relationships in the interests of preserving the RSSC aims.
- Never disparage the capabilities of others.
- Do not use mobile phones, cameras, etc. in any way that annoys others and ensure these are switched off during rehearsals
- Respect other people's property and personal belongings.

Working Together

Effective teamwork is part of a successful event. You can contribute to your group by

- Valuing the contribution of the people with whom you are working
- Working co-operatively and encouraging contributions from all members of your group
- Participating effectively without belittling the contributions of others
- Seeking guidance and assistance if you are concerned that personal relationships could have a detrimental impact on you
- Contributing positively to your chamber group or ensemble and attempting all musical tasks requested.

Violent, Rude and Aggressive Behaviour and Language

The RSSC Committee has zero tolerance of violence at the camp. Any violent, rude or aggressive behaviour or language should be reported to staff, who will deal with it according to the camp rules.

Annoying or Dangerous Items

If an object you bring to the camp is a nuisance or hazard to campers, staff or Camp Clayton itself, you will be offered a choice:

1. Place the object in storage provided by camp staff,
2. Arrange to have the object taken away from the camp at your effort and expense, or
3. Leave the camp without a refund.

Examples of this include but are not limited to:

- Mobile phone rings in rehearsal – place phone in box for duration of rehearsal.
- Talking on mobile phone while roommates are trying to sleep – phone locked in office until morning.
- Playing radio while roommates are trying to sleep – radio locked in office until morning.
- Taking photos without requesting or receiving permission – camera locked in office for entire duration of the camp.
- Carrying water pistol without clear permission – water pistol locked in office for entire duration of the camp.

Camp staff will not touch your property without your permission.

3. Respect for Rules

Follow the Instructions

All campers must follow directions given by the Camp Staff. In addition, all campers aged under 18 years must follow directions given by their Camp Parent for the duration of the camp.

If you believe that any direction is unlawful or unreasonable you have the right to question this. Our staff should be open to positive and constructive suggestions about their decisions. If you believe a direction is unreasonable then outline your concerns and ask for clarification. If you still believe the instruction is unreasonable you should ask for advice from other staff members. If you are waiting for higher level advice, you should generally carry out the instruction unless you believe it is obviously unlawful or unreasonable or if it could endanger a person's life or safety.

Camp Clayton Rules

Camp Clayton has rules of its own which must be followed. If you don't, you'll make the Camp Clayton staff unhappy, which we will deal with according to the rule below.

These include:

- No alcohol/smoking/drugs permitted on site.
- No persons of the opposite sex are allowed in the main site cabins.
- All meal times are set and Camp Clayton staff require us to be on time for these.
- Campers and visitors must park in the designated area only, **not** near the office area.
- Supervision is required for the games room and some special activities.
- All cabins must be properly cleaned before departure.

There are additional rules relating to use of facilities including the games rooms and trampolines and also relating to room cleaning standards. A copy of these rules will be provided to all campers.

'Don't Be Evil' Rule

Whenever the RSSC Committee makes rules, campers find loopholes. This shouldn't surprise us, since string players are intelligent people. In fact, we think you're intelligent enough to know how to behave without pages of rules to follow. Instead, our only other rule is this: if something you do at the camp makes anyone unhappy, you're going home. 'Anyone' includes tutors, camp parents, your parents, office staff, Camp Clayton staff, concert audiences, wildlife and other campers. 'Going home' is without a refund and at you or your parents' expense.

This Code of Conduct has been prepared by the Launceston Youth and Community Orchestra's String Camp Committee for the benefit of all RSSC participants and in the interests of promoting the LYCO aims for this event.
